


In difficult social circumstances in 1999, during the NATO bombing, Jenny Hyatt gave a speech at a peace gathering in Westminster Palace. On that occasion, she read a message from Slavica Bršić, a psychiatrist and then leader of the organization Center Srce, who provided support over the phone to individuals in trauma. She described the challenges she faced while trying to help a large number of people.


The funds raised during the speech were used **to grant Center Srce** the first operational grant to operate its psychological support helpline.

This event prompted the establishment of the Balkan Fund for Local Initiatives (BCIF), the precursor to today's Trag Foundation. It marked the beginning of a long-term process of supporting the development of local communities.



BCIF began its operations through the Active Communities program. From the beginning, donations were intended for registered associations and informal citizen groups. The supported initiatives have always resulted from needs identified by local groups and organizations within their communities. The projects we support are not thematically limited and are the product of the ideas, energy, work, and dedication of the people involved in them.


We believe that a community is not a collection of individuals but is primarily made up of the interactions individuals have to achieve common goals, which are based on the values of solidarity, respect for diversity, equality, and responsibility. We believe in the potential and power of active and united citizens to influence change in their communities, whether they are connected by a specific physical space (geographical territory), online space, or a common interest or need.



In the first five years, we awarded 175 grants, supporting local communities through projects focused on civic engagement, integrating marginalized groups, environmental protection, and promoting ethnic tolerance. We launched projects to restore public spaces and strengthen the capacities of organizations from local communities.

Since 2007, BCIF's office in Montenegro has become the local grant-giving foundation under the Fund for Active Citizenship—fAKT.


In 2014, BCIF changed its name to **Trag Foundation** without abandoning its mission of supporting citizens in initiating positive change.


